<p><u>ATTENDED FUNERAL (funeral directors charges only)</u></p> <p>This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation</p> <ul style="list-style-type: none"> - Taking care of all legal and administrative arrangements - Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral directors premises) into the funeral directors care. - Care of the deceased person before the funeral in appropriate facilities. <p><u>UNATTENDED FUNERAL</u></p> <p>This is where family or friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.</p> <ul style="list-style-type: none"> - Cremation (funeral director's charges plus the crematorium fee.)² - Burial (funeral directors charges only) 	<p>£1200.00</p> <p>Not Offered</p>
<p><u>FEES YOU MUST PAY</u></p> <p>For an Attended or Unattended burial funeral, the burial fee. ¹ In this local area, the typical cost of the burial fee for local residents is:</p> <p>For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee.
